Many of us raised very valid concerns about the case on planning grounds for a case previously turned down for about 40% less houses than was before us. Quite apart from several points i raised about the planning issues, i said i thought the increase in numbers of dwellings was just sought because the applicant thought we were in a weak position; we certainly are!

The acting Chairman proposed acceptance and I seconded it expressing my extreme reluctance, but the vote went against us and a second motion to reject was carried. Given that out of a cabinet of 5 that motion was proposed by one of them and seconded by another i would like to sit in on the next cabinet meeting".

#YouSaidWeDid - What matters to you

Your priorities are chosen quarterly and are based upon information gathered through NHL (Neighbourhood Link), social media, local engagement, and emerging crime trends. You have stated that the following key themes are important to you. #YouSaidWeDid

Priority 1 - ASB, We will be patrolling hot spot locations within the area showing a high visible presence to deter offences from occurring. We will be working with partner agencies to tackle ASB where appropriate and will deal with offenders as per our anti-social behaviour incremental approach.

Priority 2 - Burglary, We will be patrolling hot spot locations within the area showing a high visible presence to deter offences from occurring. We will also be investigating incidents, working with forensics and residents to try to identify offenders and will take action against those offenders as appropriate.

Priority 3 - Road Safety, We will be utilizing beat surgeries to educate motorists and issue traffic offence reports and section 59 anti-social behaviour notices to drivers committing offences or using their vehicles in an anti-social manner.

#WeDid - What we are doing

As always, we have been busy on the beat for the past month conducting patrols around Glenfield, Kirby Muxloe and Leicester Forest East and covering anti-social behaviour hotspots including Morrisons in Glenfield. Residents had also reported concerns in relation to drug taking on Stelle Way in Glenfield so patrols were made there too.

We have been completing enquiries in relation to burglaries and some anti social behaviour in Leicester Forest East and have been knocking on residents' doors and viewing CCTV footage to help identify any perpetrators. Do you own a motorbike/moped etc? Please ensure yours is secured with locks, a tracking device and that it is locked away in a secure location. In the burglary I have been assisting with the suspects broke into a garage to try and steal a motorbike so please ensure yours is secure.



Reports were made to us in relation to youths entering an unoccupied property on Barry Drive in Kirby Muxloe and causing damage, 2 of the young youths were seen on electric scooters leaving the premises after being challenged by a neighbour. Enquiries are ongoing to identify the youths.

We are aware of cars racing along the A50 in Glenfield, unfortunately this is a regular occurrence and often has spectators. We cannot stress the risks these drivers are not only putting on their own lives but that of other road users and pedestrians. As a local beat team we are doing what we can to combat this and although this occurs regularly we still rely on members of the public to notify us when this is happening as we cannot be there all the time. We are working in conjunction with our roads policing unit and response officers to identify these drivers.

The force has bought two state of the art speed cameras to tackle speeding and illegal car racing at car cruises across the force area.

Working with local community safety partnerships, we have secured Section 106 funding to buy the cameras. Section 106 funding is a financial contribution made by developers to mitigate the impact of development and provide necessary infrastructure.

We have bought two 'Trucam2' cameras approved by the Home Office. These cameras combine a speed detecting radar with a video recording function. They can be used to capture offences; record moving footage and provide a high-definition image which can be processed without the need to stop the vehicles at the scene.

Speeding at car meets across the force area has prompted complaints and some driver behaviour is proving extremely dangerous putting lives at risk. Officers have also sent warning letters to offending motorists and seized vehicles. We would also ask members of the public to keep reporting offences so we can continue to take action.

Last month we were in Kirby Muxloe at a coffee morning engaging with residents at Kirby Muxloe Free Church. Thank you to all who came along, it was great to see you all. We are holding another beat surgery in March, please see below for details.

Minister rejects rail freight hub

Blaby District Council is delighted plans for the Hinckley National Rail Freight Interchange (HNRFI) have been rejected.

The Council received a letter today from the Secretary of State for Transport, Heidi Alexander MP, confirming the refusal.

The Council had opposed plans for the 662-acre hub, earmarked for a huge expanse of countryside between the M69 and the Birmingham to Leicester rail line. Lying southwest of Elmesthorpe and on the edge of Burbage Common, the rail hub was the brainchild of developers Tritax Symmetry.

Council leaders repeatedly warned the rail hub and warehousing scheme would destroy vast swathes of the District and have far-reaching adverse highways, environmental and social impacts.

Classed as a Nationally Significant Infrastructure Project, which initially began in 2018 the final say on the scheme lay with the Secretary of State for Transport.

Following an in-depth, six-month examination by the Planning Inspectorate last year the Minister was recommended to reject the plans.

In September 2024 Ms Alexander's predecessor, Louise Haigh MP, agreed, saying she was 'minded to refuse' the project. However, she gave developers, Tritax Symmetry, more time to submit further evidence in support of their application. A new decision date of Monday 10 March was set.

Reacting to the announcement, Councillor Terry Richardson, Leader of Blaby District Council, said: "I am delighted and relieved the Minister has listened to the overwhelming opposition from the Council and the public and rejected these proposals. Common sense has prevailed. At last we have clarity and residents can move forward without the threat of this monstrous development over their heads."

Councillor Ben Taylor, Portfolio Holder for Planning, said: "I'd like to thank our residents for the time and effort they put into voicing their concerns. I'd also like to thank our own officers and project team for the sterling work they have done to defend our District from this ill-considered scheme."

Local government in Leicestershire is changing

The government wants to reduce the number of councils in areas like ours and make things simpler and more efficient.

This will mean new unitary councils are created – authorities which deliver all services.

They will replace the district and borough councils and the county councils.

Developing proposals

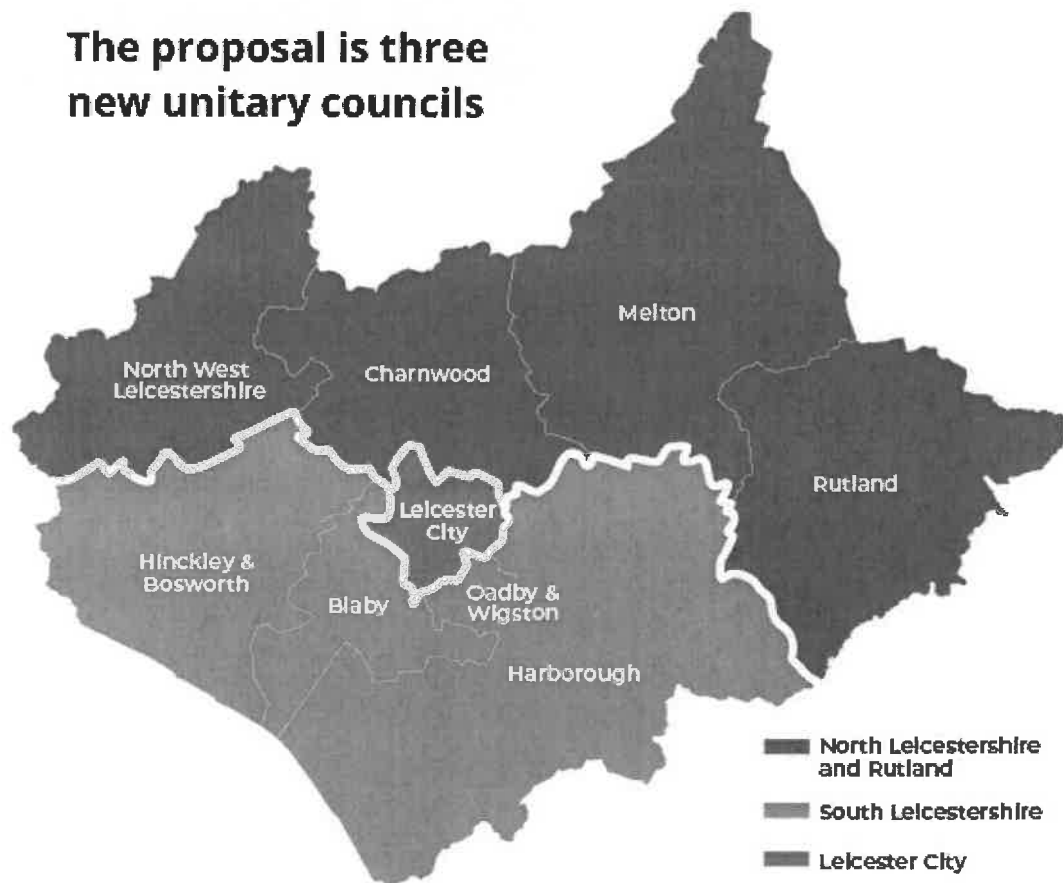
The Government has invited the area to submit plans for future council structures. This is also about unlocking devolution and bringing powers and funding to the region.

The seven district and borough councils in Leicestershire and Rutland County Council are working together to look at how we can make this work best for local communities.

From the work we've carried out so far, a preferred model for local government structures in Leicester, Leicestershire and Rutland is emerging. That model is for three unitary councils for our shared area:

- **One to serve North Leicestershire and Rutland**
an area currently served by Charnwood, North West Leicestershire and Melton district and borough councils, and Rutland County Council)
- **One for South Leicestershire**
an area currently served by Blaby, Harborough, Hinckley & Bosworth and Oadby & Wigston district and borough councils
- **One for the city of Leicester**
based on its existing boundaries

The proposal is three new unitary councils



The benefits of three unitary councils

This approach ensures councils remain **connected to people and place**, are **accessible** and **accountable**, **efficient** and have **simple structures**.

These are initial ideas. We need to do much more work, including engaging with our communities.

Good afternoon,

I am contacting you to make you aware about a pilot scheme for on-street electric vehicle charging points which LCC are going to be rolling out this year within your parish.

The pilot scheme looks to provide approximately 80 on-street charging points across the county, so as part of the County's proposal's this would equate to the installation of one charging point in Glenfield and Blaby. The charging points would be pole-mounted and of a modest scale and would include a comparably smaller feeder pillar. All equipment associated with the scheme is to be installed on Highway land within the ownership/responsibility of County Highways.

The pilot scheme is envisaged to have a duration of 15 years and the units would be maintained by Wenea, who are the installers. Depending on the success of the scheme, it might be the case that additional charging points are installed, but I am told that this is a number of years away and is entirely dependant on the pilot scheme's funding.

Blaby officers have met with representatives of LCC, who have informed them that the proposed locations for each charging point are within Glenfield Conservation Area and Blaby Conservation Area, respectively. Please see the attached document for details of approximate locations.

The installation of these charging points has deemed planning permission under Part 12, Class A of the GPDO, and therefore, does not require the submission of a planning application to ourselves for their installation. However, LCC recognise that the sites are in sensitive locations and have sought to inform us about this scheme along with seeking our feedback and suggestions based on our local knowledge of the environment and constraints.

For example, officers have informed LCC that we would prefer the charging point upstands and feeder units to reflect the colour scheme of the street furniture within their respective environments – in this instance, that would be black for Glenfield and dark green for Blaby.

We do not have an intended date for installation as of yet, but it is likely to be this calendar year.

Putting communities at the heart of future local government services

An emerging preferred model for new local government structures which puts residents at the heart of public services and ensures councils stay connected to communities has been outlined.

The Leaders of the seven district and borough councils in Leicestershire and Rutland County Council have set out their current thinking and initial preferred way forward for the reorganisation of councils in the area.

It follows the publication of the Government's English Devolution White Paper, which advocates not only for the devolution of powers and funding to the regions but requires all councils in two-tier areas to submit proposals to reorganise into unitary authorities.

Having reviewed the options and considered how best to secure the benefits of devolution and ensure the right balance between scale and maintaining connections with communities, there is a clear case for three unitary councils to serve the region. One to serve North Leicestershire and Rutland, one for South Leicestershire and the third for the city of Leicester (based on its existing boundaries).

The district councils and Rutland County Council are clear that this would enable areas to retain a strong sense of place identity, would ensure the new councils remain connected to their communities and would facilitate opportunities to work with partners across neighbourhoods, while making significant savings and enabling more effective service delivery.

The districts and Rutland council leaders remain clear that Leicestershire County Council's proposal for a single unitary for the whole of Leicestershire would be too cumbersome, too remote and inaccessible for local communities, and will fail to unlock the benefits of devolution.

The Leaders said in a joint statement: "We don't believe the current system is broken, but if it has to change it is absolutely vital we get this right for our communities, as what we do will affect how public services are delivered for many years to come. That's why we are taking a very balanced and measured approach and have put collaboration, evidence and communities at the heart of our considerations.

"We have attempted multiple times to engage with the County Council to seek the best outcomes for our communities but they have consistently refused to work with us and they are now pushing forward with a unilateral, unbalanced and outdated proposal from six years

ago which failed to find support then. A single county unitary for 800,000 people covering hundreds of square miles is far too large.

“To be clear, nothing has been finalised, and today we are sharing our initial ideas. We will be engaging with our stakeholders and communities and want to hear their views so that collectively we build the best possible future for local government across Leicester, Leicestershire and Rutland.”

The district councils and Rutland County Council will launch some initial public engagement during week commencing 24 February 2025 and want to stress there will be ample opportunities to get involved both now and throughout the process over the coming year.

This first phase of engagement will inform the councils' interim plans for reorganisation which must be submitted to Government by 21 March 2025. As the process continues, there will be a much wider and more comprehensive package of public engagement to fully inform the final proposals which must be submitted in November.

Under the preference for a three-unitary approach:

- The areas currently served by Charnwood, North West Leicestershire and Melton district and borough councils, and Rutland County Council, would be served by one unitary authority (North Leicestershire and Rutland)
- The areas currently served by Blaby, Harborough, Hinckley & Bosworth and Oadby & Wigston district and borough councils would be served by another unitary authority (South Leicestershire)
- Leicester City would continue to be a unitary authority based on its existing boundaries.

The approach would deliver significant savings and ensure a strong focus on neighbourhoods, community partnerships, and preserve local heritage and civic identities.

The three authorities would have broadly similar populations of 400,000 residents and be part of a strategic authority across Leicester, Leicestershire and Rutland with an elected Mayor; securing the full benefits of a new Devolution Agreement.

No collaboration - our residents deserve better, say the leaders of district and borough councils in Leicestershire and Rutland County Council

Leaders of the seven District and Borough councils in Leicestershire and Rutland County Council have issued a joint statement following the announcement by Leicestershire County Council that it is unilaterally continuing with its proposal to create a single unitary authority for Leicestershire, albeit changed from what it had previously suggested, and now without any inclusion of Rutland.

The Leaders of the district councils and Rutland County Council said: "We are extremely disappointed that the County Council is continuing with its proposal to create one single unitary Council for the whole of Leicestershire with no discussion or engagement with other Councils. Our residents deserve better.

"This goes against the expectations of Ministers and the intent of the Government's white paper on how it wishes to see local government reorganisation developed.

"We don't believe the current system is broken, but if it is to change then we believe one single county unitary serving 800,000 residents, one of the largest in the country, would be too remote, too cumbersome, too inaccessible and ultimately inefficient and unsustainable.

"It is pleasing to see that the County Council have at least listened to Rutland who have made it clear that they do not want to be part of a large, unwieldy single unitary for Leicestershire. This rehashed proposal doesn't address the expectation that change should be coterminous with health, fire and police or that the Government expect local government reorganisation proposals that include Rutland.

"Instead, the District Councils in Leicestershire and Rutland County Council are working together and engaging with stakeholders to develop proposals which will deliver localised, high-quality, efficient and sustainable public services for Leicester, Leicestershire and Rutland.

"Our proposals, which we will submit before the deadline of 21 March 2025, will set out how many new Councils would strike the right balance between size and maintaining a strong local connection to communities. We must, and we will, keep the local in local government.

"Any new unitary Councils should reflect the way people live their lives in that area and be aligned to where people live, work, shop and play.

"We are therefore exploring options for smaller unitary authorities which will serve our local communities' needs better, but also enhance their future prosperity

“Our proposals will be evidence led and backed by engagement with local communities, businesses and organisations. We will ensure they all have a meaningful voice in the process.

“Local democratic accountability in any new structures is also important, elected members are representatives for communities they serve.

“As the first initial deadline is very tight, we are carrying out some initial engagement with stakeholders who represent a wide range of people, communities and sectors to help shape our interim plans.

“A more comprehensive package of public engagement will follow this summer, and Government will also carry out a consultation on any final proposal so there will be ample opportunity for people to get involved.

“We want what is best for our residents of Leicester, Leicestershire and Rutland and our door remains open to the County Council to work together on achieving this.”

Hi,

Again, to clean up Kirby Road, I have continued picking litter 150 metres past DPD towards the motorway and again directly opposite the filthy DPD operation. I have collected a great deal of industrial waste that I know has come from their site. There are dozens of DPD dockets and DPD paper, polythene wrapping, work labels and plastic coffee cups etc., I have written to DPD and all occupiers of Mill Lane Ind., Est., and I have stapled a few notices around the area where these workers pass by. Not on Council property.

There are three heavy blue bags of rubbish at the entrance of DPD. It may just resonate, but I doubt it. I have picked more waste and litter from Elm Tree Ave., to the Square and around the Square. There is a blue bag that needs collection by the bin in the Square not forgetting the ones adjacent to DPD. Please.

After last week's efforts picking up rubbish, first thing Monday morning, there was litter by my house and Kirby Road leading to the estates dropped by workers eating their breakfast. Whether you like me saying this or not, many of the workers were not born in the U.K. Most DPDs are Asian. I have today collected scores of Asian chewing tobacco foils around the bus stops on Kirby Road used by the workers. Not everyone drops litter but many do.

It would be nice if Parish and Blaby could be more proactive and write to the companies concerned. It doesn't have to be officially threatening but a friendly reminder that residents live nearby. I have spoken to many people in Glenfield and they despair at the situation we all find ourselves in.

Further to my recent complaint and notice of local litter picking by myself, I write..... I was given a number of blue bags and a litter picker (after mine broke) by Beverley at the Parish Council offices where I was lucky enough to meet and chat to my local councillor Mr. Nick Chapman. Both Beverley and Nick were gracious to listen to my complaints mainly about the neglected Glenfield area.

I have explained to your good selves for years, on many occasions that, Kirby Road suffers from litter and drive by littering. A lot of the litter comes from foot traffic going to and from the trading estates. This is quite obvious to any one with intelligence, as some of the same litter is constantly reoccurring.

I have just spent three tiring hours trying to pick up litter in the other direction from my home, towards the disgusting trading estates. I can honestly say as a council, you have never in recent years, picked litter properly around this area..... For 350 Mtrs. on both sides, over three struggling hours, I have collected five heavy, full blue bags of litter consisting of general rubbish, cans, bottles, gas bottles, car parts, and industrial waste etc.,

I have struggled to collect in the deep thorny hedgerows of thistles and brambles but cannot collect all as it has become so embedded over the years. Perhaps your operatives have better equipment and protective clothing. I would kindly ask that you arrange a deep litter pick from DPD onwards towards the motorway. I have attached pictures that show the rubbish collected along with a picture of the blocked drains embedded rubbish and a sore trigger finger.

Would you please arrange to collect the rubbish sited opposite the entrance to Mill Lane trading estate where as usual there is more fly tipping.

I am a 76 year old pensioner with a wife who is suffering mental health issues due to the constant problems in the area and, who will no longer walk our dog around here. We travel to other areas to do this to get away from the scruffy surroundings. Charnwood always seems much nicer.

I am aware of your staffing problems but other councils manage better in my opinion. I've seen with my own eyes.

Finally, due to industrialisation, Kirby Road requires special attention. PLEASE.

Once again thank you for listening.

This spring, the Council will be reviewing our existing ROWIP and producing a draft document which sets out a long-term vision to develop and manage the public rights of way network in Leicestershire.

Engagement is an important part of this process, and the Parish Councils knowledge will be invaluable in informing the ROWIP.

The Council is keen for you to provide input as part of the public engagement exercise by helping identify the priorities you feel should be included. You can do this by completing a
